The 2008 Award Competition

The Research Committee chaired by Dr. Byron Marsolais selected the winners of the Jacquelin Perry and Vernon Nickel Awards for 2008. The recipient of the J. Perry Award was Dr. Matthew E. Oetgen for his paper entitled "Orthopaedic Management Improves the Early Rate of Osteoporosis Treatment after Hip Fracture." Dr. Oetgen is currently a resident at Yale University. He will receive \$2,000 for travel expenses to present his paper at the ORA Specialty Day Program in San Francisco on March 8, 2008. The recipient of the V. Nickel Award was Nicolas O. Noiseux for his paper entitled "The Effect of Sitting Pressure on Ischial Blood Flow in spinal Cord Injured Patients vs. Non-Injured Controls." Dr. Noiseux receives \$1,500 for travel expenses to present his paper at the Annual Meeting next September 2008.

Established in 2005, the purpose of the Orthopaedic Rehabilitation Association Endowment Fund is to provide funding for research and education so that the functional nature of persons with musculoskeletal disability can be improved utilizing surgical and non-surgical methods in their care.

Emphasis will be made on requests related to orthopaedic rehabilitation projects which include all of the traditional orthopaedic subspecialties. This also includes such areas as amputation surgery, prosthetics, orthotics, neuromuscular disorders and the various neurological disorders which defy easy classification. All disciplines are eligible for funding from this fund. Emphasis is placed on interdisciplinary care and priority given to proposals that involve both clinicians and researchers.
